(Club) that all the information in this application and in the applicable Stud Service Certificate is valid (i.e., true, accurate, complete and not misleading); b) authorizes the Club to take such lawful steps as the Club, in its sole discretion, deems necessary or appropriate to investigate the validity or invalidity of any such information; c) irrevocably agrees that if any of such information is found to be invalid and the breeder(s) knew or should have known it was invalid, he or she shall defend, reimburse, indemnify, and hold the Club, and each of its Directors, employees, and other representatives harmless from any and all costs and expenses, including attorney fees, directly or indirectly caused by, resulting from or incurred in connection with such invalidity or investigation; and d) agrees that the Club, by accepting this Application for Registration of a Litter, shall be entitled to the full benefits of the provisions set forth in this paragraph, whether or not the Club ever issues registration for this litter.

STUD SERVICE CERTIFICATE

(Not to be used when fresh chilled or frozen semen are used)

The owners of the Stud Dog and Brood Bitch should determine ahead of time the terms and/or fees for the required service, and what arrangement will be made if breeding was effected for a Stud Fee Puppy should the bitch rear one puppy only. It is customary to complete the Stud Service Certificate and make payment for Stud Service at the time it occurs. Stud Fee Puppies should be selected prior to three (3) months of age to allow for timely registration. To avoid misunderstandings, specific terms and fees should be put in writing prior to any breeding taking place.

Only Cavaliers registered with or eligible for registration with the CKCSC at the time of mating, shall be used for breeding. A Cavalier who has been restricted from breeding shall not be used unless the Restriction has been lifted by the person(s) who originally imposed it and the revocation is recorded by the Registration Office, PRIOR to the breeding.

If either the stud dog or brood bitch is foreign born and not already registered with the CKCSC, USA please refer to the section in the Registration Handbook, entitled Registration of a Foreign Born Dog. Eligibility for registration must be established **BEFORE** the proposed breeding takes place.

The CKCSC, USA, Inc. will not register any dog which is sired by or out of a Cavalier owned by any person who is suspended, expelled or denied CKCSC, USA privileges where the breeding date is shown to be subsequent to the date of disciplinary action.

Lack of compliance with the above requirements may place the owners of the sire and dam in violation of the Code of Ethics, and the mating may result in puppies that are not eligible for registration.

There shall be no agreement of terms for stud service, mating, registration of a litter, transfer, or terms of transfer of a dog, or any other Club procedure, which places the breeder, owner or any member in violation of the By-laws, the Code of Ethics or Policies of the CKCSC, USA, Inc.
